UNDERSTANDING THE ILLINOIS LEGISLATIVE PROCESS

Your pension fund is governed by Illinois Law, and Lawmakers in Springfield have the power to change or alter your benefits – so it's important to understand how laws are passed and how you can participate in the legislative process.

BASIC INFORMATION

- Legislators are elected in even numbered years.
- Primaries are held on the third Tuesday in March. General elections are held on the first Tuesday in November.
- The Illinois House of Representatives consists of 118 members who represent 118 different Districts. Each Representative's District includes about 109,000 constituents.
- The Illinois Senate has 59 members. Each of the Senators has approximately 218,000 constituents.
- All legislators have two offices a local office in his/ her District and an office in Springfield.

SPRING INTO ACTION

Take these steps now to protect your pension.

- 1. Share your e-mail address with RTAC. Send an e-mail to rtac-webster@sbcglobal.net. Changes can happen quickly and e-mail is the fastest way to reach you.
- 2. Educate yourself about your pension and health insurance (see page 6). Find information at www.rtac.org, and pension information on CTPF's Education and Advocacy page at www.ctpf.org.
- 3. Participate in the legislative process.

 Know your local elected representatives and make sure you vote.

 Primary elections are coming up March 18, so make sure you do your research, investigate your incumbents' voting records, and make informed decisions. Look up your legislator at www.rtac.org.
- 4. Make an appointment to visit your local legislator. See page 5 for tips on planning a visit.

RETIREE'S TEACHING CERTIFICATES/LICENSES

In 2013, the Illinois State Board of Education began the process of converting Illinois educators' teaching/supervisory certificates to licenses. As one concludes his/her career as a professional educator, it is worth reflecting upon whether one might wish to stay active in our profession beyond the Chicago public schools. Private and parochial schools as well as universities hire retired CPS educators to serve in a variety of capacities. Some limit their hiring to former teachers who have maintained their professional certificates/licenses.

The Illinois State Board of Education's website includes information as to what a retired educator should do to maintain his/her professional status. When a current certification is set to expire (usually every five years), it can generally be converted from active to valid but inactive. The ISBE website has additional information: www.isbe.state.il.us./certification.

BECOME A LEGISLATIVE ADVOCATE

Legislators are politicians who represent the needs of their constituents. You can take an active role in the legislative process by advocating for your pension and ancillary benefits.

THE ROLE OF ADVOCATES

- Help share information about important issues.
- Build and maintain positive relationships with legislators.
- Provide credible and reliable information about issues.
- Regularly contact legislators and/or staff members at their local offices.

TIPS FOR VISITING

- Call to schedule an appointment.
- Arrive at your meeting on time.
- Consider asking your legislator to pose for a photo with you.
- Limit the time for your conversation.
- Be respectful and positive about the issue you are discussing.
- Ask the legislator, if s/he will support your position before you leave.



- Provide/leave written information about RTAC or your issue (see www.rtac.org).
- Be sure to indicate that RTAC's professional lobbyists are Bukola Bello, John Carr and Dick Lockhart.
- Report your legislative contact to RTAC's office and send a photo (if available) to office@rtac.org.
- Follow up with information if appropriate and a thank you note after your visit.

DO NOT...

- Hesitate to talk to a legislator because s/he will ask you a question you cannot answer. You can always follow up with more information.
- Argue, criticize, or complain about the legislative process.
- Criticize legislators or their organizations.
- Make promises which you cannot keep or "burn bridges."

LOCATING YOUR LEGISLATOR

The RTAC web page www.rtac.org has a legislator look up function. You can also find current contact information at www.ilga.gov.

LEGISLATIVE OFFICES

Each legislator has a Springfield and District office staffed by personnel who interact and communicate with constituents.

LEGISLATIVE SESSION

The Illinois legislature is in session from January through May 31 every year and is followed by an autumn 'veto session.' The Governor can call a special session at other times.

BILLS

Every law starts out as a bill. Each bill must have a sponsor. Generally 6,000 to 7,000 bills are introduced during each session. Once a session ends (May 31), bills can be held over and voted upon during a 'veto' or a special session. If a bill fails to become a law during a session, it dies. It can be reintroduced during the next session.

THE COMMITTEE SYSTEM

The House and Senate move legislation through a committee system. A committee holds hearings to review the 'pros and cons' of proposed legislation, and then votes on whether the bill should be sent forward for a vote by the entire chamber. If a bill does not move out of committee, it dies.

VOTING

Once a bill moves out of committee and receives a positive vote in the House or Senate, it moves to the other chamber and follows the same process. If the bill passes both houses, it is sent to the Governor who can sign or veto the legislation.

ADDING UP THE COST OF HEALTH INSURANCE

Last December, the Illinois General Assembly passed pension "reform" legislation for members who participate in four of five statewide pension plans. The legislation eliminated the use of pension fund dollars to pay for health insurance. While this legislation does NOT currently impact our pensions, we at RTAC are concerned about the prospect of legislators introducing similar "reforms" to our benefits.

Retirees on fixed incomes are the most vulnerable to the increasing cost of health care. Although inflation overall has remained relatively flat recently, health care costs have more than doubled in the last 10 years. CTPF retirees must pay for post-retirement health insurance, and many do not receive "free" Medicare Part A.

CTPF members receive a health insurance premium subsidy (currently 60%) to help make insurance more affordable. This subsidy is not

guaranteed and is subject to change annually. The amount CTPF can spend on health insurance is capped at \$65 million per year. As costs rise, the subsidy available to members falls. The information below shows the amount an average retiree must spend on health insurance, and the impact that losing the subsidy could have.

THE IMPORTANCE OF YOUR CTPF HEALTH INSURANCE SUBSIDY...

The charts below show the annual and monthly cost of insurance for an average single member in a CTPF PPO plan, with and without the CTPF health insurance subsidy.

WE CAN'T AFFORD TO LOSE

According to the US Bureau of Labor Statistics, the average American household spent 4.9% of its income on health care costs in 2013. The average CTPF retiree currently spends much more – between 7-13 % of his /her income on health insurance, even with a subsidy. If we lose the subsidy, retirees could be forced to pay much

more – between 22-33% of their average income on health insurance. We can not afford to lose our health insurance subsidy.

TAKE ACTION NOW

The best way to protect the subsidy is to reach out and contact your Illinois legislators and to tell them how vital the health insurance subsidy is to your retirement security. Your elected representatives need to understand the cost and impact that cuts to the health insurance premium subsidy would have on your retirement security and your health.

^{*}Members with 40 quarters of Medicare credit receive Part A at no charge. If you do not qualify for "free" part A, you must pay for this coverage. Everyone pays for Part B, Supplemental, and Part D coverage. CTPF does not subsidize the cost of a spouse's coverage.

FROM THE DESK OF THE PRESIDENT

As I write this message, all I can see outside is snow and more snow. It seems the coming together of so many snowflakes, too many to count, but easily seen and their impact felt by all is something to behold.

To you my members of RTAC, too often we forget about the impact others have upon the quality of life

during our retirement years. Just as with snowflakes, there is strength in numbers. As retirees we can collectively have an enormous impact on our elected representatives in the Illinois General Assembly. As seniors, we tend to be treated as the problem or the "Silent Majority." Our issues are not heard, nor understood. And if they are heard, they are often dismissed.

Our General Assembly members were happy to receive our votes in the election. But it's questionable if they really are committed to representing us as retirees; we who taught and educated Chicago's youth.

Yet, this spring the question arises as to how will we be impacted when the Illinois General Assembly addresses Chicago's pension revenue deficit. Collectively, we each must make it our goal to visit our legislators so they can hear our story, our plight, and our insistence on why we need to maintain our pensions, the annual increase, and our health insurance subsidy. We

must insist that the Chicago Board of Education and/or the State of Illinois meet their obligations to the Chicago Teachers Pension Fund (CTPF). They must be reminded that their 1995 legislation and subsequent actions have caused the revenue shortfall which has decimated CTPF since 1995.

Just as snowflakes can clog traffic, as RTAC members, we must clog the phone lines, the Internet and the legislators' offices. Be sure to communicate with your State representative and senator. We must be seen and heard. If each of us conveys the message loudly and clearly, we will make a difference. It has been said that silence concedes consent. Under no circumstances should we be silent when it comes to pension reforms that diminish retired Chicago public school educators fiscal well-being.

Be sure to visit, call and/or write to your Illinois senator and representative before and after the March 18th election.

EXECUTIVE DIRECTOR'S MESSAGE

As RTAC enters its 88th year, we realize that the mission that James Armstrong and his fellow founders focused upon is still at the forefront of our existence. We continue to focus upon protecting your pension and your ancillary benefits.

We depend upon our pensions, our annual cost-of-living increases, and especially our health insurance subsidy. These three elements enable us to live decently in retirement.

CTPF members receive a subsidy to help offset the cost of post-retirement health insurance. In 2014, the current \$65 million health care subsidy enables each CTPF annuitant to have a 60%

subsidy. As insurance costs increase, the percentage will be reduced. If Illinois legislators eliminate our health care subsidy, each of us will have even far greater health insurance obligations. See page 6 for more information.

RTAC and its lobbyists are working together to prevent an outcome similar to the State systems; but we need you to do your part. Contact your state legislators and help them understand the negative impact that losing your health insurance subsidy will have on your financial security in retirement.

Speak up and speak out – now. We can't afford to be silent. See page 5 for more ideas on contacting legislators.

USER NAME, PA55WORD AND P!N ADVICE

Target and several other major retailers recently suffered a huge data breach. Over 100 million account names, passwords

and PIN numbers were stolen. This information is then sold on the black market for as much as \$10 per account. There is a big profit to be made. Thieves will often try the same user name, password and/or PIN on other accounts of the same person in the hope that they can profit from other accounts that were not originally breached.

For this reason you should never use the same user name, password and/ or PIN for more than one account. The problem then becomes how to remember the user name, password and/ or PIN for each individual account. One way is to use a common core of letters for the user information, passwords and/ or pins and then alter them in a manner that is representative of the place you are using them.

EXAMPLES

- 1. For a 4 digit PIN, most keypads have letters on each key, so you could use a common 2 digit number (53 for example) and add the initials of the account as the other two characters. For a Discover Card PIN use DC53 (3253), for the Private Bank use PB53 (7253), for Target Stores use TS53 (8753), etc. This will reduce the possibility of someone using your PIN on another account.
- **2.** There are several ways to make a password more secure. Use numbers or symbols in place of characters. 'S' could be 5, 'i' or '1' an exclamation mark!, 'o' a 0 (zero), etc. (See the title of this article). My favorite is to replace the

'at' with @. i.e. Matt becomes M@,
Atlanta becomes @lanta, etc. However,
you should **not** use the same password
everywhere. You might do the same
thing with your password as you would
with the pin, insert characters that are
representative of the use. For example,
if you currently have 'score1' as your
password, you could change it to 5c0re!
for all of your accounts and then add the
two initials for the account. 5c0re!@DC
for Discover Card, 5c0re!@PB for the
Private Bank, etc.

You should also change your password once a year. The change can be as easy as adding a character or number to the beginning or end but do not just add a 1 as it is the most popular change. Adding a 7 or 8 to the beginning or end is the best since they are the least used digits.

Remember, in this era of on-line access and transactions, your financial health could depend on how secure you make your accounts.

KEEPING YOUR (AND YOUR FRIENDS') E-MAIL SAFE

The September 2012 RTAC *News Bulletin* included an article I wrote that focused on your-email safety. The core messages included: 1. Do not open or respond to any e-mails that ask you to verify any information such as passwords, birthdays, etc. 2. Do not click any link if you do not know exactly what site it goes to . 3. Do not click on any link in a one line e-mail without a good explanation of its relevancy.

It is also important to realize that the way you **send** e-mail can jeopardize your and your friends' computers. If you send an e-mail to a number of people with their names and addresses

in the **TO:** line and **any** one of them has an infected e-mail program **all** of the people you sent the message to can become infected. Some malware can read your disk and send your confidential information to unknown places or lock a computer and demand payment to unlock the computer.

How can you avoid this? Send the message to yourself (put your e-mail address in the **TO**: line) and then use the **BCC**: option of your e-mail program for everyone else. (BCC stands for Blind Carbon Copy.)* This will do three things: 1. You will get a copy back so you know it went out.

2. The recipient list is not displayed nor is it available to malware on other computers. **3.** If a recipient prints the message they will not need to wade through a possibly long list of addresses before reading the message.

For the safety of your (and your friends') e-mails, please learn to use the **BCC:** feature. This will help to ensure everyone's e-mail safety.

SAMUEL DOLNICK (1918-2014)

The RTAC/CRTAF Board of Directors regrets to report the passing of Samuel Dolnick, our long time colleague and President of the RTAC San Diego Satellite. Mr. Dolnick served in the U.S. Army in Europe in WWII. During his full life and career, Mr. Dolnick was a significant member of the Chicago public schools professional community serving in a variety of positions from 1940 -1978. Mr. Dolnick began his career as a teacher at Stockton Elementary School and he concluded it as Principal of Von Steuben High School. He also worked as an instructor at the Chicago Teachers College, University of Illinois, Chicago Campus, and DePaul University. He also helped RTAC's members who either resided in or near the San Diego area maintain their linkage to our organization.
