RTAC Celebrates 90th Anniversary



In February 1926, ten retired Chicago Public School educators were moved to act to protect the lives and security of 70 colleagues who had been dismissed by the Chicago Board of Education on December 9, 1925, because they were age 70 or older. James E. Armstrong led this group which resulted in the establishment

of the Retired Teachers Association of Chicago. The group filed suit to prevent the unlawful dismissals, launching a legal battle which eventually resulted in the reinstatement of the teachers, and the development of legal protections and voluntary retirement with the 1927 passage of the Miller Act. The actions by a dedicated group of members set the stage for decades of activism on behalf of retired CPS educators.



CANDIDATES SOUGHT FOR 2017-2018 RTAC DIRECTORSHIPS AND EXECUTIVE BOARD



SPRING NEWS UPDATE

RTAC's Legislative Advocates' Spring 2016 Report

Editor's Note: RTAC works on behalf of retirees through many channels, and engages advocates who educate Illinois legislators. This report sums up work done in 2015 and looks ahead to 2016.

RTAC achieved a significant legislative victory on February 11, 2016, when our tax levy legislation, HB 4579, was approved by the House Committee on Revenue and Finance by a vote of 9 - 0. Executive Director, Arlene Crandall, traveled to Springfield, Ill., and gave excellent testimony on behalf of RTAC members. The bill's sponsor is Rep. Marcus C. Evans III (D-Chicago).

The bill passed the House of Representatives with a vote of 98 to 14 on March 3, 2016. It has now moved to the Senate. RTAC urges members to contact their State Senators and ask them to VOTE YES for HB 4579.

The City of Chicago sent a spokesman who objected to HB 4579.

Our appreciation goes to Representative Evans for his leadership in sponsoring this vital RTAC legislation. RTAC members, we extend a big "Thank You," but we cannot become complacent. We want a strong "yes" vote to achieve passage in the Senate, so the legislation can move on to the Governor who must sign it. Our work with this bill is just beginning.

The bill restores the tax levy to fund CTPF pensions. The measure passed with a vote of 9-0. The Illinois House voted 98-14 in favor of the measure.

There are other bills that are relevant to RTAC and that may progress during the current legislative session.

HB 5681 is an initiative of the Pension Fund and would create a Task Force to deal with health insurance.

HB 5745 provides that a person who first becomes an annuitant after the effective date, the service retirement pension shall not commence more than a year prior to the date of the Funds' receipt of an application for the benefit.

HB 4798 prohibits payments for unused sick or vacation time in calculating pensionable earnings and salary, and includes other matters in the 46-page bill.

RTAC's 2016 Legislative Agenda

On Wednesday, February 3, 2016, the RTAC Executive Board, Directors, and Past Presidents voted to pursue the following legislative agenda.

RTAC encourages lawmakers to support and Vote YES for legislation which:

- Restores the CTPF tax levy to ensure a stable revenue source for pensioners, HB 3695 and HB 4579
- Secures equitable State of Illinois Funding for Chicago teachers' pensions
- Opposes 'pension holidays' for the Chicago Public Schools
- Stabilizes the CTPF health insurance program
- Increases retiree representation on the CTPF
- Maintains the independence and fiscal integrity of the CTPF
- Supports educational funding that meets the needs of all Ill. children.

stated RTAC President David T. Peterson. "Legislators' attention must be focused on the personal impact which our pensions have on us. Our lawmakers need to understand that reducing pensions or other benefits hurts people – these cuts are not just numbers on a spreadsheet."

Participation in the initial event was strong, and made a difference, as HB 4579 passed

out of the Illinois House shortly after the Day of Action. Keep up the good work, and make a point of visiting legislators in their local offices. A visit is an excellent way to advocate for your pension and RTAC's legislative agenda.

WEBMASTER'S MESSAGE Computer Security: a safe computer means a happy user Webmaster Roy Coleman

One of the biggest concerns with any computerized system is hackers and viruses compromising the system. This includes but is not limited to: Microsoft Windows, iPads, iPhones, Android phones, etc. The two biggest sources of attacks and infections come through e-mail and unsecured wifi connections. (See my article on page 6 of the September 2012 News Bulletin at rtac.org/NB.html). Even though there is some protection built into all systems, additional anti-virus software is strongly recommended. There are a number of free programs available that have been highly rated. Although McAfee and Norton's received the highest rating, they are not free. I personally use *BitDefender* or *AVG anti-virus* on my computers (only ONE per computer -NEVER install two anti-virus programs on the same computer). For Windows 10, Microsoft has included their 'Windows Defender' program which is rated good, but there are better ones available.

ADDITIONAL TIPS FOR WINDOWS 10

Windows 10 has some default settings that you should be aware of and fully understand. By default an app (the new term for program) can access your camera, turn it on and watch you. Also by default Cortana (Microsoft's digital assistant) is on and listening to just about everything you say. Do you REALLY want your computer to watch and listen to what you are doing? (Think "Big Brother" from George Orwell's 1984.)

My suggestion would be to go into 'Settings' (click the Windows Icon in the lower left and pick 'Settings') then 'Privacy.' Go through the entire list of options, one at a time, and turn everything off (move the slider(s) to the left). A couple of exceptions might be if you are using Skype – leave the general 'Camera' setting and the 'Messaging + Skype' on, but turn the remainder off and also do the same for the 'Microphone.' If you have other applications that stop working when the settings are changed to 'Off.' You can always go back and turn them on. If you are using Windows 7 or Windows 8 you might also consider changing the settings, but it is more difficult than in Windows 10.

MORE TO BE WORRIED ABOUT

Recent news stories have shown that the computer systems on late model cars can be hacked and override what the driver is intending to do (like steer or stop). At the hacker DefCon Conference in Las Vegas convention last August, a device was demonstrated which can record the wireless signal sent to open your car or garage door and then replay the signal at a later time allowing unauthorized access. This is particularly worrisome for anyone that has a 'keyless' car. (If your car requires a key to start it, a thief may be able to get in, but still could not easily steal it.) My STRONG suggestion would be take any recall for your car seriously as the manufacturers are aware of these problems and are upgrading their software whenever a problem is discovered.

For more on this, do an Internet search on 'car computer hacking.'

PRESIDENT'S MESSAGE DAVID T. PETERSON

Did you take the L.E.A.P.? I'm, still flying. Your response to the challenge of our day of action, Legislative Education and Advocacy by Pensioners (L.E.A.P.) Day, has been excellent.

Our L.E.A.P. Initiative culminating on February 29, 2016, demonstrated your efforts to educate legislators and advocate on behalf of our pensions. RTAC is committed to ensuring that our Illinois General Assembly legislators, present and future, act in accordance with the fact that the 'pension problem' does not arise from our benefits but from the funding shortfall of the Chicago Teachers' Pension Fund (CTPF). The shortfall began in 1995 when the Illinois General Assembly diverted our pension levy away from CTPF, which enabled subsequent "Pension Holidays" which directed pension funds into the Chicago Public Schools operating fund.

Don't buy the legislative refrain "Oh, I wasn't here when that occurred, I'm not responsible." This isn't a question of responsibility for the past. We know that falls on CPS and those legislators who supported the raid on our pension fund. We are concerned with the responsibility of the present and future.

WHAT SHOULD LAWMAKERS DO?

We can't solve the problem, **but** lawmakers can by supporting RTAC's legislative agenda. Lawmakers can:

- enact legislation to restore our tax levy, providing stability to CTPF,
- pass legislation to ensure the stability of our health care subsidy,
- pass legislation giving retirees a greater voice in the management of CTPF,
- refuse additional "Pension Holidays,"
- enact legislation ensuring CTPF's fiscal integrity and independence.

As we reflect upon the current situation as it impacts retired Chicago public school educators as well as current CPS teachers, one has to be appreciative for the action taken by our predecessors. Our RTAC predecessors recognized the need to stand together and fight for the retirement security and rights of CPS teachers and pensioners in the early part of the 20th century. Their actions set the stage for decades of advocacy and activism by RTAC members.

We are also gratified that our current Retired Teachers Association of Chicago Executive Board, Directors, and Past Presidents continue the mission which began 90 years ago to serve without remuneration to protect and preserve our economic security.

Going forward we expect that the Illinois General Assembly may propose a new amendment to the Illinois Constitution which will target our annual cost of living

increase (AAI). This is also the moment to recall that in November 2012, there was a referendum on the General Election ballot which would have negatively impacted the annual cost of living increases which enable us to address inflationary costs. We believe that there is a strong possibility that we may need to undertake similar action in 2016 to prevent such a constitutional change.

Now is the time to contact your legislators to express the need for our retired Chicago public school educators to maintain what they worked for throughout their careers. We also need to prepare ourselves to enlist our families and friends to defeat negative legislation.



James F. Ward, RTAC Past President and Executive Director, and Chicago Teachers' Pension Fund Executive Director and Retiree Trustee

The RTAC Executive Board, Directors, and Past Presidents were saddened to learn of the passing of James F. Ward, former CTPF Executive Director, CTPF Retiree Trustee (1997-2013), RTAC Past President, RTAC Former Secretary and formerly RTAC Executive Director on Wednesday, February 10, 2016.

Tributes continue to pour in from RTAC members and others who came to respect Jim for his brilliant grasp of all issues related to the Chicago Teachers Pension Fund and the Illinois Pension Code. Richard Lockhart, one of RTAC's legislative advocates, stated:

"Jim seemed to have memorized the Illinois Pension Code. He knew the Illinois Pension Statutes backwards, forwards, and in all ways. Nobody could ask him a pension question that he couldn't answer immediately."

Jim's CPS career began with his first assignment as an accounting teacher at Kelvyn Park High School. From there he progressed to a thirty year career at the Chicago Teachers' Pension Fund from which he retired in August 1997 following twenty years as its Executive Director. In Fall 1997, Jim was elected to the CTPF Board of Trustees where he represented retirees beginning in November 1997 through October 2013. In September 1997, he joined the Retired Teachers Association of Chicago and he started as a member of the Board of Directors in 1999. In 2001, he became RTAC's first Executive Director. In 2002, Jim was elected to serve as RTAC's Board President for the Biennium 2003-2004. Subsequently, he served as RTAC's Board Secretary until health issues impacted his ability to continue to serve in 2014.

In 2015, Jim was awarded the James E. Armstrong Award, acknowledging his lifelong, dedicated service and work ensuring the protection of retired CPS educators' pensions. We extend our sincere condolences to his wife Deborah O'Connor, son Jason, and all of Jim's extended family, friends, and colleagues.
