Focus on Springfield



RTAC has worked on behalf of Chicago's Retired Teachers to protect pensions and benefits for more than 90 years, holding legislators accountable and protecting the rights of retirees. The work continued this spring as the 100th Illinois General Assembly opened and our organization took decisive action to support our members and RTAC's 2017 Legislative Agenda.

SB 1354 AND HB 3071

RTAC supports HB 3071 sponsored by Illinois Representative Robert Martwick (D-Chicago), and SB 1354 sponsored by Illinois Senator Michael Hastings (D-Frankfort), which would increase our representation from three seats to four on the Chicago Teachers' Pension Fund (CTPF) Board of Trustees. There are currently 12 Trustees on the CTPF Board; 6 are active members and 3 retirees. The number of retirees and beneficiaries covered by the Fund

has been increasing steadily while the number of active members has declined. Wednesday, March 1, 2017, Linda R. Williams, 1st Vice President, traveled to Springfield to testify on behalf of SB1354 at the Licensed Activities and Pensions Committee (see photo at right). RTAC encourages all members to support this important legislation by contacting local legislators and asking them to vote YES on these bills.

"We know that when we work together, we can achieve success," said RTAC President Patricia B. Kubistal, Ph.D. "This past year we have seen our tax levy restored and much of the credit goes to our members who worked to make sure that Legislators understood the importance of stable funding. We hope that we can achieve the same success with our current legislative agenda, and we're counting on our membership to help share the message."

RTAC Endorsements 2017 CTPF Retiree Trustee

In November 2017, Chicago Teachers Pension Fund retirees will elect three CTPF retiree trustees to represent the Fund's

retired Chicago Public School educators.

Any candidates wishing to secure the Retired Teachers Association of Chicago endorsement for their candidacy must send an e-mail with the following information:

- One-page professional resume; and
- Personal statement of 300 words or less outlining the specific goals and objectives which the candidate expects to undertake during his/her term of office as a trustee representing retirees. A candidate who has previously served as a trustee should include information about his/her previous accomplishment at CTPF.

Candidates seeking RTAC's endorsement are also expected to appear in person and make a three minute presentation to the RTAC Executive Board and the RTAC Directors at the June 7, 2017, RTAC Board meeting.

RTAC Legislative Advocates' Spring 2017 Report

Editor's Note: RTAC works on behalf of retirees through many channels, and engages advocates who educate Illinois legislators.

This report looks ahead to 2017.

The Illinois General Assembly is in session and will adjourn May 31, 2017. Pension legislation in the form of bills, amendments to prior bills, and proposals to amend the State Constitution will be introduced and voted on in February, March, April, and May.

RTAC's legislative advocacy team of Bukola Bello, John Carr, and Dick Lockhart lead the group's efforts to stop harmful legislation in Springfield.

This report reviews current legislative efforts of interest to RTAC members.

HJRCA 18

House Joint Resolution Constitutional Amendment 18 is a troubling proposal which aims to amend the Illinois Constitution pension protection clause.

In Illinois, the Legislature can put a proposed Constitutional Amendment on the November ballot with a three-fifths vote of the House and Senate. This must take place by early May, which means it will first be voted on by members of the House and Senate Executive Committees in March or April. If approved, the measure will appear on the statewide ballot in November 2018.

HJRCA 18, introduced by Joe Sosnowski (R-Rockford.), would **repeal** the clause in the Illinois constitution that specifies that membership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof shall be an enforceable contractual relationship,

the benefits of which shall not be "diminished or impaired."

This provision, has been upheld by the courts and is the basis for pension security for our members.

We must defeat any effort to repeal this clause when it comes up for a vote in the House Committee in the next few months. RTAC's Advocacy team is prepared to lead in that effort.

We will focus on defeating that proposal while it is still in the House of Representatives, and your assistance will be required. Also, we urge all RTAC members to reach out to other CPS retirees and encourage them to join RTAC now.


SB11

A pension reform proposal continues to make its way through the Illinois Senate. The President of the Illinois Senate sponsored a major pension reform package, SB11, that radically changes benefits for some Illinois State employees and teachers.

While SB11 does not impact current retirees, it does affect current Chicago teachers. One of the troubling sections requires employees to make an irrevocable election to reduce the current 3% compounded AAI to a simple interest calculation that is maxed out at 3% simple interest. This seemingly small change will cost current teachers thousand of dollars in pension income when they retire. RTAC has not taken a position on SB11.

SB 1354

SB1354, sponsored by Senator Michael Hastings (D-Frankfort) adds a fourth retiree trustee to the CTPF Board of Trustees. The measure would amplify the retiree voice in Fund governance,

This is appropriate given the increasing numbers of retirees joining CTPF ranks.

We urge your support on SB 1354 and encourage you to reach out to your individual legislators.

CHALLENGING NEWS

Fellow RTAC members, sometimes it is best to look at challenges first.

One might think that Illinois' pension difficulties are unique. However, that is not the case. A November 14, 2016, *Wall Street Journal* article, "Low Rates Hammer Pensions," focused upon the distressed plight of governmental agency pension funds across the world.

The article identifies the causes of the problem – higher longevity rates, low interest rates, risky investment strategies, two recessions, and underfunding. Also, at present there are fewer employees

contributing to pension funds. According to the article, the pensions of more than 100 million government workers around the globe are in jeopardy.

When pensioners' incomes stagnate, their purchasing power is diminished, and local economies are negatively impacted.

Two situations reflect the problem clearly. First, it has been a decade since the Netherlands-based Stichting Pensionenfonds ABP, which is Europe's largest pension fund, provided its retiree annuitants with an annual cost-of-living increase. In Japan, where 25% of the population is pension eligible, pensioners can expect to have their pensions reduced as their ages increase.

Recognizing that our situation is not unique is small comfort as we reflect upon our personal concerns. As of June 30, 2016, our Chicago Teachers Fund (CTPF), had assets which only covered 52% of its liabilities to present and future

retirees. This is why every retired CPS educator needs to maintain ongoing contact with legislators to express our concerns and remind them that they need to take positive action on our behalf.

BETTER NEWS

Last year the Illinois General Assembly passed SB318 which reinstated our tax levy which ensures stable funding. RTAC is working to ensure that the levy becomes a reality, not just a possibility.

Current CTPF retirees almost equal the number of current CPS educators, but we only have 3 out of 12 seats on the CTPF Board of Trustees. RTAC is supporting HB3071 sponsored by Representative Robert Martwick, and SB1354, sponsored by Senator Michael Hastings, which increase our representation from three seats to four. Please be sure to inform your Illinois Senator and Representative that you want them to VOTE YES for these two bills. Working together we can amplify our voices and reach our goal.

PRESIDENT'S MESSAGE

I want to begin by thanking you for the opportunity to serve as your president for the next two years. This is my first column, and I look forward to working on behalf of our members to make sure that RTAC continues to uphold our long tradition of protecting CPS retired educators.

I will use this column as a space to answer your questions and provide information you may find helpful as you navigate retirement.

LEGISLATIVE ISSUES

Among the many things retirees hold as important are their pension check and their health insurance. During these challenging times, RTAC is monitoring legislation which impacts pensions. To be an effective force RTAC needs your support by contacting legislators to vote on issues which impact our pension checks. I thank you for all of your past efforts of contacting your legislators. I am counting on you to be vigilant about legislation, and to continue to respond to our alerts when we reach out and ask you to contact your legislator.

HEALTH INSURANCE

Health insurance is an issue of national concern. Health costs, including prescription drugs, will continue to rise. Currently, CTPF provides its members

with a 50% subsidy for their health insurance premiums. The State of Illinois does not provide us with funds for health insurance. The State of Illinois allows CTPF to take money from our pension fund in the amount of \$65 million dollars per year, and use it to subsidize health insurance premiums. With the increase in the number of retirees and the increase in health insurance premiums, our subsidy has gone from 90% of our monthly insurance premium to its current 50%. As these trends continue the subsidy may be less in the years to come because the amount CTPF can spend has been capped at \$65 million.

At age 65 every American is expected to apply for Medicare. Individuals who have acquired 40 quarters of Social Security coverage receive Part A (hospital) coverage free. To determine if you have 40 quarters of coverage, contact your local Social Security Office. Those who have not acquired forty quarters of coverage must pay for Part A. Part B coverage, which pays for doctor's visits, physical therapy, etc., and Part D, prescription drug coverage, are additional costs.

All CTPF-sponsored Medicare plans include Medicare Part D prescription drug coverage. It's important to remember that if you are currently enrolled, or plan to enroll, in a CTPF Medicare insurance plan for 2017, you should not enroll in an additional Medicare Part D prescription drug plan, or you will lose all CTPF health insurance coverage. Some individuals with higher incomes will pay more for Part D coverage (IRMAA). Medicare will bill you directly for this cost. The CTPF Health Insurance Handbook has more information about Part D drug coverage.

Retirees often ask, "If the CTPF plan covers prescription drugs, why do I have to pay Part D?" The answer is that CTPF Medicare Plans include Part D insurance in their coverage. A third party, either

Express Scripts or Humana (depending on your plan), administers the prescription drug programs for CTPF participants.

WINDFALL ELIMINATION

All CTPF retirees are subject to the Windfall Elimination Provision which says that a retiree who receives a pension from a governmental agency in addition to Social Security may receive a portion of the Social Security check to which they are entitled. For example, if you were entitled to a Social Security check of \$1,000, your payment may be reduced by as much as 60% so you receive \$400. From that \$400. Medicare Part B and Medicare Part D premiums would be deducted. If you do not have sufficient funds from your Social Security check to cover the premiums for Part B and Part D, you are billed for the difference. With increasing costs, retirees who once had these amounts deducted from their Social Security check, are now being informed that their Social Security check is insufficient to cover these costs. They, therefore, must make up the difference. It's important to make timely payments to avoid losing your health insurance coverage.


