# Returning to Work?

A CTPF retiree may return to work, but there are rules to follow to keep your pension from being jeopardized. A retiree who returns is restricted as to how many days, during each school year s/he can work in a Chicago Public School or charter school, without affecting their pension and health insurance subsidy.

It's critical to maintain a record of days worked and complete required reporting if you return to work. CTPF does not track this information for you. Visit www.ctpf.org for information and be vigilant in tracking to protect your pension.

### Chicago Retired Teachers Aid Fund Lends a Helping Hand

The Chicago Retired Teachers Aid Fund (CRTAF), which became an incorporated not-for-profit organization in 1986, has its roots in the Retired Teachers Association of Chicago (RTAC).

The RTAC archives reveal that over the years some members were concerned about former colleagues who were unable to sustain themselves due to aging, family and/or personal illnesses, securing suitable housing, etc.

These members took it upon themselves to help in a variety of ways – providing transportation to medical appointments, locating appropriate housing, and securing small stipends from the RTAC Board to help with financial challenges.

Following the passing of Ms. Ferol Potter, RTAC President for the biennium 1975-1976, a \$50,000 bequest from Ms. Potter's estate led to the 1986 founding of CRTAF. CRTAF's bylaws state that its purpose is "to assist indigent retired Chicago public school teachers through grants-in-aid and in such other financial matters as may be appropriate."

CRTAF provides modest stipends to individuals with ongoing health conditions or diminutive pensions. In addition, there are many days when individuals call to seek guidance with matters related to their physical and financial well being. Our staff provides guidance and referrals as appropriate.

If you know of a retired CPS educator who may be in need of assistance, please have that individual call the office at (312) 750-1522 between 10:00 a.m. and 3:00 p.m. on weekdays when school is in session.

Prospective grantees must complete an application to determine their eligibility for

assistance. Grant recipients must provide annual financial updates. All applicants' information is kept confidential.

The Fund's Board of Directors meets in January, April, August, and October of each year to review applications for financial assistance. Each spring they also conduct home visits.

Gifts and/or final bequests to CRTAF allow the organization to continue its mission and offer a lasting legacy to the profession. CRTAF is a 501 (c) 3 charitable organization, and gifts are tax deductible as allowed by law. Consider making a gift to celebrate, honor and/or memorialize individuals of your choice. ## Spotlight on Springfield: RTAC Legislative Advocate Report

Editor's Note: RTAC works on behalf of retirees through many channels, and engages advocates who educate Illinois legislators.

Last December,

lame duck Chicago Mayor Rahm Emanuel had this to say about Chicago's pension funding crisis and your "Automatic Annual Increase," (AAI).

"Think about it," Emanuel began, "What kind of progressive, sustainable system guarantees retirees 3 percent annual compounded pay increases when inflation has been at basically zero and current employees have at times been furloughed, laid off, or received one percent raises?"

Emanuel then went on to say the way to deal with this pension crisis would be to eliminate your AAI by amending the Illinois Constitution.

But Emanuel was wrong on the economy and wrong on the law that protects your modest pension benefits.

First, *Bloomberg News*, and other media outlets have reported expenditures related to healthcare are expected to outpace inflation over the next decade. And, for retirees who generally have more healthcare needs than the rest of the population, the mayor's assertion that inflation is or will be 'basically zero' is incorrect.

Second, the Pension Protection Clause of the Illinois Constitution provides for your retirement security by making a teacher's pension an enforceable contract. It states: *Membership in any pension or retirement system of the State, any unit of*  local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired. (Ill. Const. 1970, art. XIII, §5.)

However, we are all aware that there are many Illinois voters who do not understand that Illinois public agency retirees, like retired Chicago public school educators, do not get Social Security. They are envious of your pensions and do not understand that your pensions are the foundation of your economic security.

The cost of all the goods and services you purchase with your pensions are not decreasing, they are increasing. In order to maintain your financial well being, you need your pension and the AAI.

Therefore, now is the time to advocate for what you earned. Your pension is not a gift. You must 'teach' your legislators that a promise was made to you and that it must be fulfilled. Now is the time for every retired Chicago public school educator to advocate for his/her economic well being. The 101st Illinois General Assembly includes the largest 'freshman class' in 25 years. Now is a good time to 'teach' some imporant facts.

Over the next several months, RTAC is asking you to meet with your State Senators and Representatives – especially those freshmen. It is easy. Each has a local district office within a reasonable distance of your home. Make an appointment to meet and share the following message: As a retired Chicago public school educator, I depend upon my monthly pension check. It is not a gift. While I worked, I paid 9% of each paycheck into my pension fund. Now, I receive the payment that I earned during the years of my teaching career. When I receive my monthly check, I spend it in Illinois, and return the money back into state and local economies.

### **PRESIDENT'S MESSAGE**

John A. Butterfield, RTAC President

#### Hello To All!

I'm John Butterfield, your recently elected President and a proud 38-year veteran of the Chicago Public Schools. I'd like to tell you a little about myself and my journey through the CPS system.

As a favor to a friend, I accepted a temporary teaching position in a parochial school in Chicago in 1962. One year turned into three and I worked as an 8th grade teacher at St. Vincent De Paul Grammar School until 1965. At that time, I joined the Navy for a four-year hitch. It was during my service time that I realized that I really missed teaching.

When I was discharged in late 1968, I had a semester of student teaching at Waller High School (now Lincoln Park High) on the north side of the city and then applied for a job in the Chicago Public Schools. I was hired as an FTB (Remember that term? Full Time Basis Substitute) for one year. They sent me to Lake View High on the north side. I loved it there; but I wasn't allowed to stay longer than a year.

Orr High on the west side was my FTB assignment in year two. This was the old Orr on Keeler between Augusta and Division. It was also an elementary school, as well as district headquarters – terribly overcrowded.

When year three arose, downtown told me I could no longer be an FTB. They assigned me as a Social Studies teacher to South Shore High on the southeast side of the city. I didn't even know Chicago had an east side!

I was at South Shore High for eleven years. It was a real eye opener for me. For every traditional student I had, there was a twin who said "I dare you to try and teach me" – so I tried.

In the summer of 1982, I applied for a CBOE program called Options for

Knowledge (various specialty programs were offered at select high schools across the city). I was accepted at Mather High on the north side. I had come full circle teaching in Chicago.

I was at Mather High for twenty-five years, the last ten as principal. I retired in 2007, and immediately got involved with RTAC. My reason for doing this was simple: I wanted to be actively protecting our pensions.

ALL OF US MUST WORK TO PROTECT AND DEFEND A PENSION WE LEGALLY EARNED. NO ONE IS GIVING ANYTHING TO US. WE WORKED FOR IT.

It has been 11+ years since I retired. Time does fly, especially when you are involved in such a worthy cause as ours. All of us must work to protect and defend a pension we legally earned. No one is giving anything to us. We worked for it.

As President I have two goals for my term in office. Like those fine educators who came before us, I want to make certain that we protect and maintain all of the provisions within our pension. I would even like to improve it, if that opportunity arises. The powers-that-be have tried in the past years to limit/reduce our pensions. The fight actually reached our State Supreme Court. Thank goodness the judges ruled in our favor; but we can't count on that always being the case. RTAC is absolutely

committed to suing the very minute any change to our constitutionally protected rights are violated. This takes money so join us in building our Legal Defense Fund. We must be prepared when (not if) they come after our pensions again. See the donation form on page page 10 in this issue of our *News Bulletin.* 

One last thought on helping the cause. Please make a point of reaching out to those retired CPS teachers you know who are not RTAC members. Ask them to join with us. This issue affects us all.

The second part of my agenda deals with technology. RTAC has been operating with a technical system – and doing wonders with it, that is keyed to the first part of the 21st century. We need to catch up, maybe even get a bit ahead of the curve. This is a costly item, but a necessary one. It is my hope that when I leave office in two years, this will be a completed item on our task list. We are presently getting bids on what is needed.

In closing, I ask you to attend our Spring Luncheon. Aside from this *News Bulletin*, the luncheon gathering is another great way to get the latest lowdown on what's going on in our retiree world, visit old friends, and have fun. Please join us. ### WEBMASTER'S MESSAGE: HOW TO HAVE "FUN" WITH LANGUAGE

Many of the words in any natural language have multiple meanings and can be interpreted in multiple ways. As teachers, we always required our students to communicate clearly, intelligently, and unambiguously.

Some of my favorite examples of ambiguity in the English language: Take a simple question – Someone makes a statement an then asks if it is True or False; the correct answer is 'YES' since it must be one of the two choices.

Have you ever been given a driving instruction to 'turn left at the stop sign' and, when you get there you ask "Left?" The person giving the instructions will usually say "Right." Does that mean turn right or that you are correct?

Someone gives you a set of directions and says, "Follow these." Does that mean they will physically move and lead you somewhere?

One of my favorite questions on my 'Christmas' quiz was "Name Santa's Reindeer." (Note that I did not ask "What are the names of Santa's Reindeer?") I would take ANY 9 words a student gave me as an answer – i.e. "I do not know the names of Santa's Reindeer." would get full credit. They named the first Reindeer 'I', the second one 'do', the third one 'not' and so on.

However, my very favorite 'fun' was when a student brought me a field trip form or some other activity sheet which asked me to excuse them from class. Invariably they would ask me to "sign this." At which point I would write 'this' on the form. Many times they would then ask me to "Please put Mr. Coleman" on the form. I would then put it on the floor and stand on it. They might ask me to "Sign Mr. Coleman" and I would take my pen and write 'Mr. Coleman' on my hand. It got so that most, if not all, of the faculty would accept forms with 'This' written on it.

Communicating clearly and unambiguously is vital for everyone and should be at, or very near, the top of every teacher's requirements.

### **EXECUTIVE DIRECTOR'S MESSAGE**

In 2019, RTAC celebrates its 93rd Anniversary as the organization dedicated to protecting retired Chicago Public School educators' pensions and ancillary benefits. As we proceed, it is important to recall how our organization was founded and how we can carry forward our organization's mission.

On December 9, 1925, the Chicago Board of Education terminated the employment of 70 teachers age 70 or above under the provisions of the *Emeritus* Rule. Some individuals impacted by that action challenged the *Emeritus* Rule in Court. The law was initially upheld, but subsequently appealed and overturned by the Illinois Supreme Court.

James E. Armstrong, who would later serve as RTAC's first President, and his colleagues determined that laws needed to be passed to protect educators. The first such law was introduced by Mr. Miller, a teacher at Lindblom Technical High School. He also served as a legislator during the summer months as that is when the Illinois General Assembly convened at the time. Miller's Law, as it came to be known, established a schedule for retirement with a pension.

As current retired Chicago Public School (CPS) educators we are the beneficiaries of Mr. Miller's efforts as well as the others who have followed him. However, as most of us are aware, the general public and others believe that our pensions are a 'gift'. We know differently. We worked and paid for our pensions with ongoing contributions from our paychecks every pay period. While we work for CPS, we do not have the option of paying into Social Security. Many retirees who did not have the option of paying into Medicare, must also pay for Part A benefits upon retirement.

Approximately one third of Illinois' 101st General Assembly, which was inaugurated in January 2019, is comprised of 'freshmen' legislators. It is in all of our best interests to introduce ourselves to our legislators, especially those of us who have new Illinois Representatives and Senators.

We need to ensure that they understand that we are dependent upon the pensions which we earned for our economic security. About 80% of us still reside in Illinois and we do have a positive economic impact on our communities and our State. Please commit yourself to introducing yourself to your Illinois State Representative and Senator and 'teach' them that you are an economic asset to your community and the State of Illinois.

### RTAC Past President David T. Peterson (1936-2018)

The RTAC Board of Directors regrets to announce the passing of David T. Peterson on November 27, 2018. David was a graduate of Chicago public elementary and high schools. He began his career as a teacher and

In the next phase of his career, he served as an assistant at the Chicago Principals Association and taught at Loyola and Roosevelt Universities.



### RTAC Former Director Nathaniel Blackman, Jr. (1930 - 2018)

The RTAC Board was saddened to learn of Nathaniel Blackman Jr.'s passing on November 19, 2018.



Nate's CPS career was highlighted by his principalship of Chicago's Metro High School, a 'school

without walls'. He insightfully and thoughtfully led this pioneering initiative that enabled its students to experience the City of Chicago as their classroom. Many of the former teachers and students of Metro have credited him with their success in high school and beyond.

Following his 1992 retirement from CPS, Nathaniel Blackman Jr. served as a student teacher supervisor for De Paul University and taught AARP Drivers' Education classes for senior citizens.

Nate joined RTAC in 1992 and became a Director in 2005. He served on several committees, including the Service Committee. His thoughtful and insightful dedication to CRTAF and its mission was reflected with substantial donations to the Chicago Retired Teachers Aid Fund.
