### RTAC 2019 Legislative Goals

Our pension fund is governed by the laws established by the Illinois legislature. RTAC employs legislative advocates to carry out the stated goals of the Board of Directors. This year, RTAC's legislative goals include:

- Stabilize a viable health insurance program for CTPF annuitants.
- 2. Maintain the independent and fiscal integrity of CTPF.
- 3. Oppose 'pension holidays' for the Chicago Public Schools.
- 4. Oppose legislation that adversely affects the AAI for RTAC members.
- 5. Continue to educate legislators on issues of concern to RTAC members.

#### Legislative Update: Return to Work Rules

RTAC supported SB1584, which increased to 120 days (up from 100 days) the amount of days a service retirement pensioner who is re-employed as a teacher may work without having his or her pension canceled. This legislation passed on May 23, 2019, and was sent to Governor Pritzker who had 60 days to sign the legislation before it automatically becomes law. Visit the RTAC website for updates. The new rules do not increase the salary amount that members can earn during the 120 days, which is limited to \$30,000 or \$50,000 for individuals who retired with 5 years of service as administrators. Members must track days or hours worked and compensation received. Exceeding the limits can lead to a cancellation of a pension, so it's important to monitor days and hours worked.

## **Armstrong Award**

#### **RTAC Dental Insurance**

RTAC members in good standing are eligible to access one of RTAC's MetLife Dental insurance plans. Option 1 offers comprehensive services and Option 2 offers a lower-cost option with limited coverage. Rates in effect since 2016 have been extended through 2021.

Both plans cover primary services such as oral exams and biannual cleanings. Dependent coverage is available. Participants can also access a vision care service plan. Information about the program will be available at the RTAC table during the CTPF Health Insurance Seminars, October 8 and 10, or call the RTAC office at 1-312-750-1522 for more information.

# Spotlight on Springfield: RTAC Legislative Advocate Report

Editor's Note: RTAC works on behalf of retirees through many channels, and engages advocates who educate Illinois legislators.

Governor Pritzker certainly delivered on his campaign promise to "Think Big," passing many big ticket items during the Spring 2019 legislative session.

"Big" proposals included passing a budget, capital infrastructure legislation, recreational marijuana legalization, antisexual harassment proposals, and Statewide gambling expansion.

What was not happening was discussion on how to tax pensions, or even gossip on how to "fix" State and City unfunded pension obligations. The State captured an unanticipated \$1.5 billion in additional revenue this year. That negated the need for policymakers to make cuts to the pension systems and allowed Illinois to make its statutorily required pension payment for this year.

That was a good outcome.

Finally, the State's \$40 billion dollar budget also contained contributions to the Chicago Teachers Pension Fund (CTPF) in two line items: \$11.8 million in appropriations for CTPF's unfunded liability and \$245 million in other contributions from the State to CTPF.

## PROGRESSIVE INCOME TAX ON THE BALLOT IN 2020

On Memorial Day, the Illinois House of Representatives passed SJRCA 1 (Senate Joint Resolution Constitutional Amendment Number 1), a resolution allowing for a constitutional referendum to approve a graduated income tax for the State of Illinois in 2020. At present, Illinois has a flat tax rate of 4.95% for all individuals. If the voters approve to change the State of Illinois' income tax from a "flat" rate to a graduated rate, the change would become effective for the 2021 tax year.

Passing this resolution was a legislative triumph for Governor Pritzker. His political message, from last year through June 1, was simple, and has been embraced by Democrats across the State: the progressive income tax will cut taxes for 97% of Illinois residents. Now, this question is in the hands of the voters who participate in the November 3, 2020, election.

While the resolution gives voters a chance to decide if the income tax structure will change, Senate Bill 687 which passed the General Assembly on June 5, 2019, sets the rates for a graduated income tax. Under this measure, single filers would pay a maximum rate of 7.99 percent on all income once their taxable income tops \$750,000. For joint filers, that rate takes effect when income tops \$1 million.

For joint filers outside of the top brackets, the rates are 4.75 percent on taxable income from \$0 to \$10,000; 4.9 percent from \$10,001 to \$100,000; 4.95 percent from \$100,001 to \$250,000; 7.75 percent from \$250,001 to \$500,000; and 7.85 percent from \$500,001 to \$1 million.

For single filers, tax rates are the same as joint filers up to \$250,000; but the 7.75 percent rate applies from \$250,001 only to \$350,000, while the 7.85 percent rate applies from \$350,001 to \$750,000.

The bill also includes an increase in a property tax credit from 5 percent to 6 percent, and a \$100 per-child tax credit for couples earning less than \$100,000 and single persons earning less than \$80,000.

## Your RTAC Membership Provides You With Legislative Influence

The legislature passed SB 1584 which increases to 120 days (instead of 100 days) the number of days a CTPF service retirement pensioner who is re-employed as a substitute may work without having his or her pension canceled. RTAC fought hard in Springfield to pass this bill in 2019.

We are also fighting hard to pass House Bill 2240, a bill to make permanent a \$65 million dollar subsidy for your health care in retirement.

That bill did not become law this year. We need your help to pass it in 2020.

It's important to remember that while your pension has a constitutional guarantee, your health insurance does not. We must work to guarantee that your health insurance cannot be eliminated by legislators.

Maintaining your membership in RTAC allows us to continue our work. We're stronger together, and we encourage you to recruit your friends and former colleagues to become RTAC members. We will continue to update you the activities in which we engage in Springfield on your behalf.

Good Day!

During my elementary school years I was a Boy Scout. Our motto was "Be Prepared" and I'm happy to say that I've tried to follow it throughout my life. One of the goals for my term as president is an upgrade to our computer system in the office.

This upgrade discussion has gone on for a number of years since we all knew it would be expensive to complete. I formed a Technology Committee in January of this year with the hope that we would complete the task in two years.

Technology committee members went right to work outlining what needed to be done. They estimated the cost could be as high as \$30 to \$35 thousand dollars. Three bids were obtained and interviews were held. The committee plan was to present the finished proposal to our board this summer with the hope that the work would be completed by January of 2020.

Another task we all need to do this summer and fall is meeting with our elected representatives and letting them know about RTAC and its mission to protect the pensions which provide our economic security. Approximately one-



questions in a small-group format on topics ranging from income tax filing assistance and updates, Required Minimum Distributions of IRA funds, protecting your assets, legal matters (Power of Attorney for Health and Property and Advance Directives), senior residential housing, long-term care, investment strategies, etc. The presenters can always schedule private appointments for those who seek individualized assistance and guidance. Our Fall 2019 seminar schedule is included on page 3.

Call the RTAC office between 10:00 a.m. and 3:00 p.m. on school days for assistance and guidance with your questions. Our staff assistants – Dianna, Eleanor, and Lynnette – and I are your RTAC resource colleagues.

Members who travel need to be aware of new requirements that will go into effect on October 1, 2020. Valid Illinois drivers licenses/IDs will be accepted by the TSA to board domestic flights until October 1, 2020. After that date, you must have a REAL ID DL/ID, U.S. passport or passport card, military ID or other federally approved document to board domestic flights. The State of Illinois is now issuing RealID licenses, which meet these requirements for travel. Depending on where and how you travel (domestic and/or international destinations; by long distance buses, Amtrak, or automobile) you will want to review your choices and learn what documents you will need to bring by visiting your local Illinois Secretary of State's Office or going online to REALID.ilsos.gov.

RTAC remembers Robert C. Konen, who passed May 12, 2019. Bob joined RTAC in 1976, following the conclusion of his 35-year CPS career as principal of Sutherland Elementary. He later worked with Encyclopedia Britannica Education Corporation. Mr. Konen's RTAC service included chairperson of the Service Committee, member of the Finance Committee, and a volunteer for the Chicago Retired Teachers Aid Fund. # Policy Change Allows Re-Enrollment Option for CTPF Health Insurance

July 18, 2019, the CTPF Board of Trustees voted to allow members to re-enroll in a CTPF health insurance plan **one time** without a qualified change in status. Previously, enrollment was only allowed once in a lifetime, unless a member experienced a qualifying event (marriage, birth, divorce, etc.). RTAC members have been vocal advocates in support of this option.

CTPF retirees, survivors, and their dependents may initially enroll in a CTPF plan once in a lifetime, unless they experience a qualifying event (marriage, birth, death, etc.) The policy change waives the qualifying event requirement one time.

Members who want to rejoin a CTPF health plan must enroll during an Open Enrollment period. The next Open Enrollment period for CTPF health insurance will be October 1-31, 2019.

#### QUALIFICATIONS

A member applying to re-enroll must have proof of insurance coverage (medical and prescription drug) as of the beginning of the enrollment period (October 1), and maintain coverage through December 31. CTPF insurance coverage will become effective January 1. Members with questions about re-enrollment should contact CTPF Member Services at 312-641-4464.
