## President's Message

#### Linda R. Williams, RTAC President

As we approach the end of the year, we are surrounded with the sights and sounds of the season. Holiday lights light up buildings giving off a warm welcoming glow. The holiday music is on the air waves and children's choirs throughout the city warm up on holiday sounds. We look forward to meals with family and friends, especially all those enticing smells from the kitchen which capture our sense of taste.

At this same time of the year our mailboxes are filled with information about Medicare Supplemental Plans asking us to change to their Plan. Our eyes and ears are also filled with similar messages from commercials advertising Medicare Supplemental Plans. Don't be fooled by all these messages; most of them contain misinformation. If you have a Chicago Teachers Pension Fund Health Insurance Plan, you need to retain it. You only need to continue to pay your Part A, B and D Medicare charges. Your CTPF Supplemental Plan is taken out of your pension check. Remember that you currently receive a 60% subsidy, and you have a prescription plan which covers all prescriptions approved by Medicare. So, toss away all those other Plans that come in your mailbox and turn a deaf ear to all the commercials.

If you do select another non CTPF plan or sign up for a prescription plan

with another group, you will loose your CTPF Health Insurance Supplemental Plan. CTPF does allow a person one opportunity to return; but it is challenging and difficult to be reinstated. So please disregard all the mailings and commercials. Don't be fooled!

Retirees 72 or older who have IRA(s) must take a Required Minimum Deduction (RMD). Please consult your financial advisor as this withdrawal must occur before December 31st.

In January you need to start gathering documents that will assist you in filing your Taxes. It would be helpful if you have a folder for these documents. Social Security sends a SSA1099 which lists your social security benefits and how much you paid for Medicare Insurance. CTPF will send a 1099R which lists your retirement income and the taxes that have been withheld. Depending upon your personal finances you might receive a 1099INT for interest you have earned, a 1099DIV for any dividends you have received and perhaps another 1099R for other retirement funds that you may have. You should receive all these documents by the end of January. Sometimes the mail is late, and the documents arrive the first week of February. These are just some of the documents you will need to file your Income Tax. You may also need other documents such as charitable donations

and property tax bills. Please consult your tax advisor for a complete list.

The Holidays are busy days but don't become distracted with temptations to change your health insurance and please establish a routine for keeping all your important tax documents.

## **Recap: Fall 2022 RTAC Seminars**

# OCTOBER 12, 2022 — BLYTH & COMPANY STRATEGIES FOR PREPARING YOUR 2022 TAX RETURN

Krista Zych and William Blyth provided the seminar attendees with information about how one should look at his/her 2021 income tax filings to ready oneself for the 2022 filing season. The impact of the 2022 Inflation Reduction Act and the Secure Act were discussed. How to minimize the tax implications of Required Distributions from one's IRA holdings and using them for one's charitable gifting were described with comparative charts.

# NOVEMBER 9, 2022 — ROY COLEMAN, RTAC'S WEBMASTER POST-HALLOWEEN MS WORD AND MS EXCEL TRICKS AND TREATS

Roy explained and described how and when to use tables and/or columns in Word, usage of basic bullet formatting and numbered lists. He demonstrated how Excel's cell formatting can be used to make the spreadsheet more informative and how the 'Enter' (or 'Return') operation can be inserted. He also showed how to split and/or combine text cell contents into multiple cells and how to use conditional color formatting to distinguish differing cell content.

# NOVEMBER 16, 2022 — RTAC MEMBER STEVEN HARA PLANNING FOR ONE'S FUTURE HOUSING DECISIONS

As we move ahead in our lives, there are times when we need to plan for our changing housing needs. RTAC member Steven Hara provided seminar attendees with the various elements that need to be considered as we decide how to proceed. He discussed the factors to consider when downsizing as well as the pros and cons of individual or group housing options. He also discussed ideal ways to sell and stage one's home and the variety of factors to consider when selecting a realtor for purchasing and/or selling real estate.

Enrollment is available in any month throughout the year. Premiums are pro-rated, and billing is semi-annual. RTAC's plans are

exclusively available to RTAC members, their spouses, and children under age 26. RTAC members enrolled in either of the Metlife dental plans also have access to the complimentary eyewear program which provides them with discounts for eyeglasses, contact lenses, non-prescription sunglasses, and LASIK procedures at a variety of purveyors.



## **Treasurer's Report**

# PRESENTED AT THE OCTOBER 18, 2022 RTAC LUNCHEON/BUSINESS MEETING

As you probably know, the Chicago Public Schools has one fourth fewer students than it did when most of us were teaching. As a result, there are fewer teachers and therefore ultimately fewer retirees. Thanks to Mr. Carlton Lenoir, the Chicago Teachers Pension Fund Executive Director, in February 2022, RTAC was able to send recruitment brochures through a third-party printer to approximately 230 individuals who retired between 2018 and 2021. This generated 91 new members; but we are still not where we would like to be.

As of December 30, 2021, RTAC had 7,828 members. As of September 30, 2022, we have 7,544 members. Over the past few years we have been losing about 300 people per year as a result of the individuals making their transitions. We continue to get new members. The majority of our members are life members. Lifetime members are not required to pay anything after they become lifetime members although they continue to receive the RTAC News Bulletin three times per year plus services from RTAC.

Per RTAC's 2021 Financial Statements, RTAC collected \$49,150 in annual renewals and \$23,300 in lifetime memberships which totaled \$72,450. We also received \$36,937 in donations.

RTAC's 2021 income was \$109,387. Unfortunately, that amount is inadequate to maintain our organization. Our expenses for the year were \$223,645. As you know the cost of everything is increasing. We are able to maintain RTAC and to make up the difference between our membership fees and donations to meet our expenses thanks to the income that is generated by legacy donations that have been received over RTAC's 96 -year history.

When you are planning for your end-of-year giving, please consider gifts to RTAC. Also, as you consider your legacy arrangements, please consider making a bequest to RTAC so it can continue to protect our former Chicago public school educator colleagues' pensions and their ancillary benefits.

Since our founding in 1926, we have been at the forefront of protecting your pensions. In 2012 we acted to protect your automatic annual increase by defeating Amendment 49 to the Illinois Constitution which would have placed control of our Automatic Annual Increases in the hands of the Chicago City Council.

We look forward to many more years of fulfilling our mission to protect you. We also look forward to your continued support. Your support is also needed to recruit CPS retirees to RTAC's ranks. # RTAC Spotlight on Springfield 2022 General Election Review

It is now safe to watch the news and check your mailbox without being inundated with ads focusing on political extremism, abortion, crime and the economy. Political arguments should simmer down - at least until families gather for the holidays.

Midterm elections typically see the party of the sitting President face significant headwinds and lose a significant number of Congressional seats. After their first two years, President Clinton lost 53 seats, Obama lost 63 seats and Trump lost 40 seats for their parties. The wave against the party in the White House also impacts state and local races. President Biden's approval ratings were perceived to be a drag on his entire party's ticket. At the time this is being written there are still a number of U.S. House of Representatives races which have as yet to be determined. However, the U.S. Senate continues to be in the same position as it has been since 2021. One Georgia U.S. Senatorial seat has moved to be determined in a run-off.

Contrary to election eve speculation, there was no "red wave" nationally.

Quite the opposite happened in Illinois. Democrats enjoyed a big night with success up and down the ticket.

Republicans struggled as the Democratic party in Illinois used gerrymandered maps, a huge money advantage and "hand-picked" opponents to bring them historic victories.

#### **GOVERNOR'S RACE**

Governor Pritzker secured a second term with a double-digit victory over State Senator Darren Bailey. Governor Pritzker defined Bailey as "too extreme for Illinois," highlighting his positions on abortion and gun rights.

Pritzker and the Democratic Governors' Association spent millions in ads

promoting Bailey in the Republican primary. Their strategy was that Bailey's positions could appeal to the GOP primary voter; but were less aligned with the majority of general election voters.

In the last two years, Governor Pritzker has spent over \$150 million on his and other Democrats' campaigns. This spending advantage enabled the Governor to blanket the airwaves and define his GOP rival before Sen. Bailey could get his message to voters. By contrast, Bailey didn't have the funding to air his first general election campaign ads until a month before the election.

#### STATEWIDE OFFICES

The Democrats swept all statewide constitutional offices during this election cycle. They held a significant financial advantage in their races as well as name recognition with four of the five campaigns containing incumbents.

In the race to replace long time Secretary of State Jesse White, former Treasurer Alexi Giannoulias defeated State Representative Dan Brady. Attorney General Kwame Raoul defeated downstate attorney Tom DeVore earning a second term. Treasurer Mike Frerichs earned a third term after he defeated State Representative Tom Demmer. Incumbent Comptroller Susanna Mendoza, as expected, bested the GOP's Shannon Teresi by 15 points.

#### STATE HOUSE

Legislative maps and spending advantages helped Democrats retain supermajorities in the Illinois House and Senate.

In the House of Representatives, Democrats appeared to gain four seats which would bring their super majority up to 77 seats from the current 73. The Democrats have defeated a few incumbents along with winning several open seats.

#### STATE SENATE

The Senate Republicans showed a net gain on election day. This is little consolation as the Democrats still maintain a supermajority.

The Springfield area was the site of the most expensive legislative race in the state where Democrat Senator Doris Turner defeated Rep. Sandy Hamilton. The candidates spent over \$5 million in funds during the race, most of which went toward ads brutally attacking each other. (That total seems like a lot of money for a job that pays \$70,000.)

#### **ILLINOIS SUPREME COURT**

Democratic candidates Elizabeth Rochford and Mary Kay O'Brien both won their races giving their party a five to two advantage on the Court. Outside groups put more than \$11 million into the races. Democrats characterized the races as a referendum on abortion. As a result of the election, now a majority of justices on the Court will be women.

# ILLINOIS CONGRESSIONAL DELEGATION

U.S. Senate

Democratic U.S. Sen. Tammy Duckworth fended off a challenge from Republican Kathy Salvi to earn another six-year term. Duckworth, an Iraq War veteran who lost both legs when her helicopter was shot down in 2004, has served in Congress for nearly a decade.

U.S. House of Representatives
Illinois lost one Congressional seat
during the remap process due to national
shifts in population. Using Congressional
maps to their advantage, the Illinois
Democratic congressional delegation
safely held all its incumbents. They also

added Chicagoans Delia Ramirez and Jonathan Jackson as well as Nikki Budzinski of Springfield and Eric Sorensen of Rockford. Illinois Democrats will now have 14 seats in Congress, one more than before the remap.

# AMENDMENT 1 - WORKER'S RIGHTS AMENDMENT

Votes are still being counted for Amendment 1, the Worker's Rights Amendment. The proposed Illinois amendment would guarantee not only the right to organize for the most common elements of collective bargaining, such as wages, hours, and working conditions, but also for "economic welfare and safety at work." The amendment is close to passage and proponents believe when all votes are tallied, there will be enough votes to add this to the Illinois Constitution.

#### ROADMAP TO RELEVANCE FOR GOP

There will be opportunities for new leadership for Republicans in the Illinois House. Following the election, Jim Durkin announced that he will not seek another term as the House GOP Leader, a role he has held since 2013. Also, six of eleven members of the House GOP leadership team either lost elections or sought other offices and will not be returning.

Former Governor Jim Edgar offered advice to the Republican party after its poor showing on election day. He said the party needs to nominate more moderate candidates in order to win and more moderate Republicans need to vote in primary elections. As Republicans serving in the minority, Edgar stated that to be relevant they are going to have to "deal with the Democratic majority, deal with a Democratic governor." Therefore, they are going to have to meet him halfway, at least. As the minority, they cannot expect to get their way; but they might be able to at least have an impact on policy when they participate in its development.

#### **NEXT STEPS FOR ILLINOIS LAWMAKERS**

With the campaign season in the rearview mirror, Illinois lawmakers can hopefully set about once again carrying out the wishes of the electorate and the citizens of Illinois.

The challenges facing the state did not go away during the campaign. Vacancies need to be filled for leadership and committee chairs including the House Pension Committee which is of utmost importance to retirees. Lawmakers hope to address gun safety, reproductive rights, public safety, and, of course budget issues and the economy. Workforce recruitment and retention across most sectors remain a major concern. Mental health must continue to be a priority. It is time to get back to work.

Late fall includes a Veto session. Early January will contain a "lame duck" session and the new General Assembly will be sworn in on January 11, 2023.
