# 2025 RTAC Legislative Agenda

On February 5, 2025, The RTAC Board of Directors approved the RTAC Legislative Committee's 2025 Proposed Legislative Agenda as follows:

- 1. Maintain the independent and fiscal integrity of CTPF.
- 2. Secure funding needed to provide a stable health insurance program for CTPF annuitants.
- 3. Oppose legislation that adversely affects the AAI for RTAC members.
- 4. Monitor proposed adjustments to legislation affecting prospective Tier 2 annuitants.
- 5. Continue to educate members of the Illinois General Assembly on issues of concern to RTAC members.
- Sustain efforts that enable retired CTPF annuitants to work as substitute teachers for up to 140 days and drivers' education instructors to work up to 900 hours annually without loss of their pension benefits.
- 7. Oppose 'pension holidays' for the Chicago Public Schools.

# **RTAC 2025 Election**

RTAC is looking forward to its 2025 Fall Officers and Directors Election. We are seeking individuals who are interested in becoming involved with RTAC's leadership. Specifically, RTAC members who have been members on or before April 1, 2025, are eligible to self-nominate for the following positions on or before April 30, 2025.

The open positions are for the biennium 2026-2027. The five officer positions are: President, First Vice President, Second Vice President, Treasurer, and Secretary. In addition, candidates are being sought to fill eight directorships. Per RTAC Bylaws, any member in Good Standing is encouraged to self-nominate for any of the positions. The RTAC Nominations Committee will interview candidates in Spring 2025. For additional information about the roles and responsibilities, please feel free to review RTAC's Bylaws which are available on the RTAC website at rtac.org/bylaws.

Qualifications for all of the positions include:

- 1. Computer competency (either Windows or Apple).
- 2. Regular access to the Internet to send/receive/respond to information and attend virtual (via Zoom) and in-person meetings.
- 3. Ability to work collaboratively.
- 4. Attendance at monthly meetings (generally the first Wednesday of the month).
  - a. At present the RTAC Board's monthly meetings are hybrid in-person and via Zoom access.
  - b. Officers and Directors should plan to attend meetings in person, whenever possible.
  - c. In-person attendance at the monthly Board meetings generates a travel reimbursement stipend.
  - d. Committee meetings may be conducted in-person or virtually via Zoom.
- 5. Recruiting new and veteran CTPF annuitants who have as yet to join RTAC.
- 6. Sharing constructive ideas to support the organization's mission.
- 7. Participating in activities which focus upon the organization's purpose.

Self-nominating candidates are expected to complete and electronically submit both the 2025 RTAC Application and Conflict of Interest forms to be considered for the positions of Officers and/or Directors. The forms are available at www.rtac.org. The completed forms are to be submitted electronically on or before 3:00 p.m. on Wednesday, April 30, 2025, to Arlene Crandall at office@rtac.org.

### President's Message

Louella B. Preston, RTAC President

As I write this message three weeks following the inauguration of Donald J. Trump as the 47th President of the United States, it is significant to reflect that neither he, nor Illinois' Governor or Chicago's Mayor have the legal, military or other experiential backgrounds that our previous federal, state, and city's top governmental leaders have possessed. We anticipate that we will be addressing a variety of challenges in this unique time in United States history.

As RTAC prepares to commemorate the centennial of its founding, it will continue to maintain its mission to advocate for and protect your economic security and ancillary benefits as retired Chicago Public School educators. Our mission will continue to guide our activities and services.

In the Winter Bulletin 2024/2025, my President's message addressed three critical issues that we continue to confront and monitor on your behalf.

The first critical issue presented is the idea that CPS' financial challenges could be solved by combining the Chicago Teachers' Pension Fund (CTPF) with the Teachers' Retirement System of Illinois (TRS). In response to that challenge, RTAC issued "The Retired Teachers Association of Chicago's Resolution in Support of Sustaining the Chicago Teachers' Pension Fund as an Autonomous Organization for the Exclusive Benefits of Active and Retired Chicago Public School Educators". The full text of the Resolution appeared on pages 8 and 9 of RTAC's 2024-2025 Winter Bulletin. This resolution was transmitted to CTPF by October 15, 2024. RTAC's ideas were incorporated by CTPF into a letter that was sent to all members of the Illinois General Assembly (ILGA) on November 15, 2024. The Presidents of CTPF, RTAC, CTU, and CPAA affixed their signatures to the letter

to firmly express their opposition to the proposed merger. Highlights of the letter are included below:

- A CTPF merger with TRS of Illinois would not be in the best interests of CTPF's active and retired members;
- 2. CTPF's distinct investment model, independent self-governance, and ongoing modernization of its technological structure enable it to extend its communicative outreach and provide stable and secure retirements for retired CPS educators since its founding in 1895;
- TRS's complex technological infrastructure, which serves 852 Illinois school districts with a broad range of differences, is confronted with a variety of challenges;
- Consolidation of CTPF and TRS into an even larger system would most likely complicate and increase investment expense due to the diverse asset allocations for the various school districts; and
- Combining CTPF with other public pension funds, particularly TRS of Illinois, could exacerbate actual risks for CPS by lowering the funding ratio of CTPF without additional Illinois State Aid to fairly and equitably fund all the stakeholder teacher pension funds.

The letter's closing stated that it was hoped that the organization's signatories clearly stated their united opposition to any merger of CTPF with other public pension systems. CTPF has served our members with excellence for over a century; and we believe it must remain an independent entity to continue doing so.

No actions were undertaken in the ILGA's Fall 2024 Veto session regarding this matter. Matthew Maloney, RTAC's legislative advocate, continues to collaborate with other advocates and lobbyists from CTPF, CTU, and CPAA regarding this issue during the Spring 2025



Louella B. Preston session, should it be included on the ILGA's agenda.

The projected inadequacy of the \$65 million health insurance subsidy that the State of Illinois provides to CTPF was our second issue. On February 18, 2025, IL Senator Robert Martwick sponsored SB1893 to increase the State of Illinois' health insurance contribution to CTPF from \$65 Million to \$100 Million beginning in FY2026. This additional amount would maintain the subsidy which has been in effect since 2005. It is imperative that every annuitant contact her/his ILGA Representative and Senator to move this bill forward to passage. Your health insurance subsidy is vital to your economic and physical well-being.

The American Federation of Labor – Congress of Industrial Organizations (AFL-CIO) Illinois' 'We Are One' group proposed legislation to adjust the "Tier 2" pension structure. It did not proceed during the Fall 2024 session of the ILGA. Matthew Maloney continues to monitor this issue in the ILGA's Spring 2025 session. RTAC does not have legislative advocacy at the federal level. However, it does have an opportunity to interact with federal legislators biennially when RTAC sends representatives to the biennial National Continued on page 7

### **RTAC Spotlight on Springfield** By Matthew Maloney, RTAC Legislative Advocate

#### NEW GENERAL ASSEMBLY TO FACE UNPRECEDENTED CHALLENGES

The Illinois General Assembly was sworn in for a new term on January 8, 2025. Democrats retain a supermajority – more than a 3/5ths majority, in both chambers. All caucus leaders remain the same, with Senate President Don Harmon and Speaker 'Chris' Welch retaining their leadership over their respective chambers.

This past election brings six new House members and three new Senators. Despite this small freshman class, the General Assembly is still relatively "young" with 38% of the elected officials having served five years or less.

Governor Pritzker and the General Assembly are staring down a massive budget hole in November 2025. The Governor's Office of Management and Budget annual Economic and Fiscal Policy Report states that Illinois faces a \$3 billion fiscal year 2026 (FY26) deficit based on current spending patterns and revenue collection. That deficit is projected to climb to \$4.1 billion in FY27, \$5 billion in FY28, and \$5.2 billion in FY29, before receding somewhat to \$5 billion in FY30.

The report cited a slowing national economy, medical inflation, and required pension contribution increases as contributing factors impacting the State's resources. Following the report, the Governor's office sent a memo to State agencies urging preparation for the impending slowdown in the economy coupled with a revenue forecast with roughly flat FY25 revenues.

To address these challenges, State agencies have been tasked with identifying spending reductions in programs that have increased in the last three fiscal years. Agencies were also asked to identify operational efficiencies and program consolidations as well as to identify potential vacant positions that can be eliminated. The Governor's Office indicated that no legislation with an increased FY26 fiscal impact should receive agency support. The State's operating budget has grown by nearly a third during his tenure, to \$53.1 billion.

Illinois faces many challenges: mandated increases in funding for K-12 schools, statutory increases in pension payments, rising medical costs, and anticipated loss of federal resources. In addition, there is a need for \$1 billion dollars for the transit systems as they face a fiscal cliff with the expiration of federal funding.

More than 6,000 bills have been introduced this Spring. Several pension bills of varying impact will be introduced as well.

The State can't forever ignore the need to fix Tier 2 pensions. At minimum, Governor Pritzker wants to bring Tier 2 into compliance with the federal 'Safe Harbor' provision. He will not support any pension proposal that is credit negative or threatens the State's balanced budget. Organized labor unveiled its recommendations starting in November 2024. However, ILGA's Commission on Government Forecasting and Accountability recently released an actuarial analysis of the union-backed pension reform plan. The report concluded that the bill, which included lowering the retirement age, as well as other cost of living adjustments would cost taxpayers almost \$30 billion through the year 2045. The final average salary calculation would cost an additional \$1.1 billion through 2045; a redo of the annual cost of living adjustment payments would add \$4.4 billion; and lowering the retirement age for Tier 2 recipients to equal Tier 1 recipients would cost \$11.3 billion. Discussions

are expected to continue throughout the Spring as the State grapples with higher expenses and reduced fiscal resources.

Illinois' massive budgetary challenges will also be impacted by federal funding cuts and/or elimination of federal programs which will result in even larger deficits. In the early days of the new administration, there was a great deal of confusion following the announcement that federal grants, loans and other financial assistance already allocated to the states were to be paused. The freeze would have impacted critical Medicaid health care dollars, childcare and Head Start programs, home delivered meals, and disease surveillance among hundreds of programs.

Illinois Attorney General Kwame Raoul joined several other states in suing the federal government to block this action. The argument stated that this action violated the powers of the Executive branch and Congress which had appropriately allocated these dollars. The federal spending freeze was later withdrawn. However, the message signaled that many federal spending initiatives and other executive actions will be subject to State and Federal lawsuits. The new administration is seeking to curtail spending through an ideological lens.

The Illinois General Assembly lawmakers are facing longer days ahead as difficult decisions will need to be made on funding, immigration, taxes, pensions, and transit.

Take a moment to call your elected officials. Thank them for taking on this important role of serving the community. Offer your perspective, your expertise and gratitude. Your voice and ideas can help guide them in these difficult times.

### **Executive Director's Message** Arlene R. Crandall, RTAC Executive Director

As RTAC prepares to commemorate its 100th Anniversary in February 2026, one has to marvel at how the organization was founded and how it has been able to stay current and ahead of the challenges which have occurred during the past 99 years. RTAC provides its members with current information about the legislative and other issues that impact our members' ongoing economic security and well-being in an environment that is continually evolving.

Although it has been recounted numerous times, RTAC was founded in February 1926 to address the wrongful action against 70+ Chicago Public School educators who were terminated from their positions by the Chicago Board of Education because they were age 70 or above. Ten men, led by Dr. James E. Armstrong, filed legal action in the Circuit Court of Cook County. They lost there; but went forward to the Illinois State Supreme Court where they were victorious. All of those terminated educators, as well as additional educators who were terminated in Spring 1926, were given the opportunity to return to their positions.

Dr. Armstrong and his nine colleagues founded RTAC in February 1926 with the express purpose of protecting retired Chicago public school teachers' economic security. During the early years of the 20th century, retired educators in Chicago and across the U.S. lacked even the most basic economic 'safety nets' to sustain them in retirement. Dr. Armstrong and his group determined that this had to change. RTAC was founded to ensure that retired Chicago public school teachers would be able to retire in dignity. Social Security did not come into existence until 1935. In 1941, Illinois opted out of having the States' public agency employees be covered under Social Security.

Dr. Armstrong and his colleagues determined that our organization would be open to all retired Chicago public school educators. Other state governments followed Chicago's example. They set an example which was followed by Dr. Ethel Percy Andrus, a Chicago native, who after concluding her career as principal of Los Angeles' Abraham Lincoln H.S., recognized the need to establish an organization similar to RTAC. She consulted with Dr. Armstrong and RTAC and set about to establish the National Retired Teachers Association (NRTA) in 1947, of which RTAC is a charter member. To date, RTAC is the only organization based upon a single school district. The other NRTA members are organized by state. In the 1950s, other workers petitioned for a similar organization that would promote their retirement needs. This led to the establishment of the American Association of Retired Persons (AARP) in 1958. AARP continues to this day to promote and advocate for the needs of U.S. retirees. Dr. Andrus died in July 1968, but shortly thereafter President Lyndon B. Johnson signed legislation to protect all older workers (age 40 and above) from being terminated or denied promotions as appropriate due to their ages.

During the second half of the 20th century, RTAC was focused on increasing its membership, securing retiree trustee representation on the Chicago Teachers' Pension Fund, and assisting CPS retirees with diminutive pensions. That commitment to the less fortunate led to the establishment of the Chicago Retired Teachers Aid Fund in 1986, courtesy of a legacy grant from former RTAC President Ferrol Potter (1975-76).

Two of RTAC's most significant accomplishments include securing three trustee positions to represent CPS retirees on the Chicago Teachers' Pension Fund and collaborating with the fund to establish a suitable health insurance program for CTPF annuitants. This effort became especially important when, in the

late 1980s, CTPF retirees were separated from the health insurance plan shared with active CPS teachers. Today, CTPF retirees benefit from excellent health insurance options thanks to the collaborative efforts between CTPF and RTAC, led by CTPF Retiree Trustee and RTAC President James Ward and others.

The '2023 Social Security Fairness Act – U.S. H.R.82' is landmark legislation that will be beneficial to a substantial number of CTPF retirees. CTPF retirees who also worked in the private sector for ten or more years and paid Social Security taxes will benefit from the repeal of the Windfall Elimination Provision (WEP). Once this is implemented, CTPF retirees should be able to receive the full Social Security benefits to which they are entitled. Up until now, we were only eligible to receive 30% of our benefits due to also receiving our public pensions.

In addition, HR82 also repealed the Government Pension Offset (GPO), which affects those who had spouses or deceased spouses to whom they were married for ten years or more and who worked in the private sector and contributed to Social Security. Those spousal/widow-widower benefits will be accessible to CTPF retirees. Implementation of these changes will take some time. # Provisions of the 2023 Social Security Fairness Act – U.S. (H.R. 82)

On Sunday, January 5, 2025, U.S. President Joseph R. Biden signed the U.S. (HR 82) 2023 Social Security Fairness Act U.S. (HR 82) which provides for the following:

1) Repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as a pension from a state or local government. 2) Eliminates the government pension offset, (GPO) which in various instances reduces Social Security benefits for spouses, widows, and widowers who also receive government pensions of their own.

3)Eliminates the windfall elimination provision, (WEP) which in some instances reduces Social Security benefits for individuals who also receive a pension or disability benefit from an employer that did not withhold Social Security taxes.

These changes are effective for benefits payable after December 2023.

If you believe you qualify for new or increased Social Security benefits, please contact your local Social Security office. As of January 6, 2025, the Social Security Administration

Retired Teachers Association's (NRTA) gatherings held in Washington, D.C. RTAC is a charter member of NRTA and is the only city-based U.S. Retired Teachers Association. The other associations represent the 50 State organizations. Prior to the pandemic, I was able to attend the NRTA biennial gatherings and was able to advocate for Social Security, Medicare, and Prescription Drug Cost Control. I met with Illinois Senators Tammy Duckworth and Richard Durbin, Illinois Congressional Representatives Mike Quigley (D-5), Jan Schakowsky (D-9), and Brad Schneider (D-10). Those repeated visits supported the passage of the 2023 Social Security Fairness Act, HR 82, which repeals the Windfall Elimination Program (WEP) and Government Pension Offset (GPO) that was signed into law on January 5, 2025 by President Joseph Biden. See the article on page 6 for more information. I and our fellow widows and

widowers were negatively impacted by the former Social Security WEP and GPO rules. We were prohibited from securing our deceased spouses' Social Security benefits after they passed. Patience will be needed for the implementation of this new legislation. RTAC will be sending 'Thank You' letters to Illinois' Senators and the Congressional Representatives who voted for HR 82. We anticipate some updates when a Social Security Representative will be providing a status report on its implementation on Wednesday, April 9, 2025 to RTAC members who register for a Zoom seminar.



# Chicago Retired Teachers Aid Fund Provides Vital Support



Since its founding, RTAC has been committed to assisting its fellow Chicago Public School (CPS) pensioners. Documents show that early in our organization's history, members of the RTAC Service Committee helped support CPS pensioners who needed guidance and assistance with financial, housing, medical, and transportation issues. The Service Committee members

would carefully investigate the retiree's circumstances. Once they determined the need for assistance, they would request support from the RTAC Board.

Ms. Ferroll Potter, 1975-76 RTAC President, left a legacy endowment which was used in 1986 to establish the Chicago Retired Teachers Aid Fund (CRTAF). The purpose of the Fund was to "assist indigent retired CPS teachers through grants-in-aid and in such financial matters as may be appropriate". It is a 501 c-3 not-for-profit organization. Contributions to CRTAF are deductible for tax purposes.

Some CPS retirees were unable to work full-length careers for various reasons. Their pensions and total household income levels

may be diminutive. If you or someone you know needs assistance in securing basic goods and services or addressing a large home repair, health-related expense, or other unanticipated essential expense, please consider seeking assistance from the Chicago Retired Teachers Aid Fund.

"The Chicago Retired Teachers Aid Fund provides a safety net for retired CPS pensioners with small household incomes in retirement. Each year we serve individuals who benefit from the generosity of their fellow retirees" said Arlene R. Crandall, RTAC's Executive Director. "Throughout the years since its establishment, our members and other benefactors have made gifts to CRTAF to honor or remember their former colleagues and friends. Some thoughtful and generous individuals also include CRTAF in their legacy plans. We consolidate these gifts to help our fellow retirees".

If you or a fellow CTPF pensioner needs financial assistance, consider applying for a grant. There is a screening process that involves the completion of an application, submitting a variety of income and expenditure documents, as well as an interview. 
